

Local Union Equity Fund



The Local Union Equity Fund was created to encourage and support local unions who wish to step up their work on equity issues. The fund aims to broaden the work of equity-deserving groups within the Union and encourage more local unions to dedicate time and resources to equity campaigns and initiatives.

The union will be allocating \$250,000 this year for the fund, which will support projects in 2025.

The fund may be used for new equity initiatives only and cannot be used to make donations to outside organizations or individuals. Twice annually, a committee, appointed by the National President will review proposals to determine which initiatives will receive funding taking into account equitable distribution amongst equity deserving groups and regions.

Application Process

Local unions wishing to submit projects for consideration must <u>fill and submit this form</u> prior to the application deadlines.

The deadline for fall 2025 applications is October 20, 2025.

Review Committee

The National President will appoint a review committee tasked with reviewing all applications submitted. The committee will evaluate the projects and make recommendations for allocated funds to the National President.

Appointments to the Committee will be reviewed at least annually and the Terms of Reference that established the Fund and the Committee will be reviewed every three years.

The Committee will also work with the union's equity departments to disseminate information on the fund and on the criteria for funding consideration to ensure that all interested local unions have an opportunity to apply.

The National President will provide an annual report to the National Executive Board on selected projects funded through the Local Union Equity Fund.

BIWOC EVENT | Local 240

This campaign seeks to inform members of the economic and educational gaps that racialized communities face due to systemic racism. The project also seeks to build community through an inperson event to discuss issues that racialized communities face, how it causes an economic gap, and ways we can work together to bridge that gap.

ORANGE SHIRT SOCIETY SPEAKER | Local 3018

A special guest speaker, Phylis Webstads, will provide education to members about Indigenous tragedies in Williams Lake, B.C., and the surrounding area, and related intergenerational trauma, to connect members and build solidarity.

AWARENESS RAISING EVENT | Local 6004

The local will host an awareness building event to address equity issues of unemployment rates, inequality, and financial instability and lack of training available to members from equity deserving communities.

RECOGNITION OF THE NATIONAL DAY OF REMEMBRANCE AND ACTION ON VIOLENCE AGAINST WOMEN | Local 531

This campaign seeks to raise awareness about gender-based violence against women, girls, and 2SLGBTQIA+ individuals leading up to the National Day of Remembrance and Action on Violence Against Women in December. The campaign includes information sharing with members starting in November in the lead up to 16 Days of Action.

RACIAL JUSTICE ADVOCATE AWARENESS AND EDUCATION | Local 62

This initiative will raise awareness, educate members, and promote dialogue through workshops and seminars about the realities and impacts of racism and racial discrimination in the workplace and union.

AMPLIFYING BIWOC VOICES IN LOCAL MEDIA | Local 87 M

Project funding will support six journalism events across Canada in 2025 to highlight the diversity of Unifor media members. The events will provide members with an opportunity to network and have a safe space to discuss diversity issues with other BIWOC media workers and their allies.

EARTH DAY EVENT | Local 87-M

The local hosted a panel discussion in April to inspire members to take action for climate justice through a panel discussion centred on themes of equity, social justice, and climate change.

PRIDE COMMITTEE DAY OF PINK CELEBRATION | Local 111

In April, the Local 111 Pride committee held an event celebrating the Day of Pink to foster solidarity and action against bullying and homophobia. Sister Bear I'Tall, a Unifor Local 2200 skilled trades mechanic, provided a keynote address speaking to the importance of educating ourselves on our history and following that knowledge up with concrete action.
